## What is Builder's Profile?

Builder's Profile is a simple web-based construction-industry focused Pre-qualification Questionnaire (PQQ) sharing service for contractors & subcontractors.



### **Builder's Profile for Contractors**

Builder's Profile reduces the costs of administering, improving & maintaining supply chain PQQ information and locating new suppliers.

### **Builder's Profile for Subcontractor & Suppliers**

A user-friendly 'complete once, share many' service that makes PQQ submission simple, and keeping information up-to-date easy

**Audit & Assessment Interface:** Builder's Profile can provide direct access to your supply chain audit partners to save time and duplication of effort.



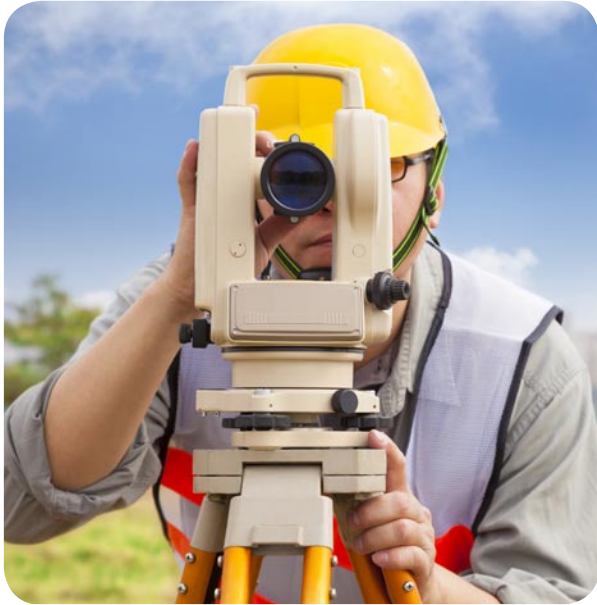
## Subcontractor and Supplier Service
